

## Request for information under the Freedom of Information Act – 2023.323 Released – 8 February 2023

Thank you for your email received 25 January 2023 requesting information regarding temporary and permanent recruitment.

Please find detailed below a summary of your request, together with our response.

An excerpt of the relevant Freedom of Information legislation can be found below:

## Section 40 – Personal information

- (2) Any information to which a request for information relates is also exempt information if—
- (a) it constitutes personal data which does not fall within subsection (1), and
- (b) either the first, second or third condition below is satisfied.
- (3a) The first condition is that the disclosure of the information to a member of the public otherwise than under this Act
  - (a) would contravene any of the data protection principles, or
  - (b) would do so if the exemptions in section 24(1) of the Data Protection Act 2018 (manual unstructured data held by public authorities) were disregarded.
